A. Guest parking near #92

B. Placement of LP Map sign near Rt. 5 entrance

Done.

C. Motion sensor lights at handicap ramp on Normal Hall

Although motion sensor light was replaced on Normal Hall near the handicap entrance, Pancione agreed to make sure it was working properly.

D. No parking on septic at Normal Hall

As the EC received word that parking on the septic at Normal Hall is not recommended, Pancione agreed to put stumps along the road there.

E. Empty propane tanks and broken furnace control at Normal Hall

Empty propane tanks at Normal Hall were reported filled, and an improperly functioning furnace control was reported as fixed.

F. Sanding/snow removal update

Pancione agreed to ask the plowers not to push snow too far down Northampton Street, and to be more thorough when plowing neglected areas.

G. Post Office insulation update

Fiberglass insulation has been installed behind the post office.

H. Trees near #55, dead near in front of #108

Pancione agreed to check some dead or dying trees in front of #55 and #108.

I. Refinancing Common buildings

A thorough examination of refinancing the Common buildings at historically low interest rates found it better to keep our current mortgage, though the EC has requested Pancione pay extra on the mortgage each month.

Other things discussed:

Pancione agreed to ask around for a space heater, gone missing from the back of the post office, and replace it should it not be found, and to replace the battery in the smoke detector there.

Pancione agreed to get quotes to repave Simpson Street, including replacing its current water line, and get suggestions on what to do about drainage there.

Louis Hasbrouck agreed to work with Pancione on a plan that would ensure back condo fees are paid.

Pancione agreed to call C. L. Frank and Co. requesting an informational session on the possible means of treating Hemlock trees against the ravages of the Wolly Adelgid.

Pancione agreed to schedule a street sweeping, projected to fall between April 15th and May 15th.

4. Continued EC Business

A. Back-up generator at #83 update

No new information is forthcoming on the approved installation of a backup generator at #83.

B. Management Vision Committee update

Report was made to the EC that the former chair of the Management Vision Committee will be unable to take up the role again; a letter has been sent from the EC to another resident requesting willingness.
