D. OLD BUSINESS

 Investment of Reserve Funds. Members of the EC held meetings with 2 investment advisers. The representative of Edward P. Jones suggested starting with ladder CD's and perhaps tax-free Municipal Bonds. The EC feels that we need to invest in order to stay ahead of inflation. MOTION: Open an investment account with Edward P. Jones. PASSED

MOTION: We will invest a maximum of \$100,000 with Edward P. Jones. **PASSED**

- 2. LPA Agreement for use of Normal Hall tower. The space needs extensive cleaning, which the EC does not feel we should pay for. Ani has agreed to pay for 2 hours of Pancione's time. We need to resolve the issue of liability. Neither LPA nor EC wants to assume the liability. Ani has insurance that will cover it and we suggest that he provide us with a rider that specifically covers the situation. At the very least we want to be explicit that HALP is not the primary insurer.
- 3. Our attorney says it's OK to post service recommendations on the website as long as we state that they are not official recommendations of the EC.

E. NEW BUSINESS

 Transition of Officers. June will likely be Darcy's and Colleen's meeting.Laura has a choice as to whether to relinquish her role as VP and assume the presidency, or to assume the role of acting President and then serve out her term as VP after the new election.Sandra's At-Large position ends at the next meeting.
